Greetings Digital Coalition members:

This newsletter is intended to provide you with further information regarding new and updated forms, many of which were mentioned during our teleconference calls on February 11 and 12. With assistance from willing builders and testers from within the Digital Coalition, we have posted the following PS Suite custom form, Accuro details and fillable PDF files to the form repository on the [SWPCA website](#)

**1. Under the Diagnostic Radiology category or by searching LHIN, MRI, CT, Spine or Knee:**

- South West LHIN - MRI Standardized Requisition
- South West LHIN - MRI Standardized Requisition + Knee Appropriateness Checklist
- South West LHIN - MRI Standardized Requisition + Spine Appropriateness Checklist
- South West LHIN - CT Standardized Requisition
- South West LHIN - CT Standardized Requisition + Spine Appropriateness Checklist

**Note:** We received information from the MRI project team after the MRI/CT forms were published that critical patient info was omitted which needed to be included to support patient care. The DC has made the edits without requiring total rebuild and testing. We took this opportunity to make a couple other changes (notably combining the spine and knee checklists with the reqs). The project team apologizes for this re-work and we are doing what we can to support these changes. We appreciate your patience, knowing that you may have already downloaded the Feb 15 version. Please replace those with files listed in the repository with an upload date of March 11, 2019.

**2. Under the Diagnostic Radiology category or by searching SJHC, Breast Assessment or Ultrasound**

**3. Under the Psychiatry category or by searching SJHC, LHSC, Mental Health**
